**AN ORDER REORGANIZING THE PROVINCIAL NUTRITION COMMITTEE OF
THE PROVINCE OF TAWI-TAWI**

WHEREAS, the concern on nutrition at the local level is one of the targets of the Philippine Plan of Actions adopted by the National Nutrition Council, particularly the eradication of hunger and poverty;

WHEREAS, the problem of malnutrition is a multifaceted problem requiring multi-sectoral mix of intervention towards its sustain reduction;

WHEREAS, Provincial Nutrition Committee is the mechanism for planning, implementing, monitoring, evaluation, and coordinating the provincial plan of action for nutrition;

WHEREAS, with the end of the term of the previous appointing authority and with a new administration taking over, there is need to reorganize and constitute the Provincial Nutrition Committee of the Province of Tawi-Tawi;

NOW THEREFORE, I, **YSHMAEL "MANG" I. SALI**, by virtue of the powers vested in me as Governor of Tawi-Tawi, do hereby order and ordain that:

SECTION 1. There is hereby organized and constituted The Provincial Nutrition Committee of the Province of Tawi-Tawi to be composed of the following:

CHAIRPERSON : Provincial Governor
CO-CHAIR : Vice Governor

SECTION 2. Functions. The Provincial Nutrition Committee of the Province of Tawi-Tawi shall have the following duties and functions:

1. Formulate and implement local food and nutrition policies, plans and interventions for nutrition improvement.

2. Monitor and evaluate the efficiency and effectiveness of the plan for nutrition improvement.
3. Identify and mobilize local resources for nutrition interventions and delivery of nutrition related support services such as conduct of nutrition education activities including counseling on breast feeding and others;
4. Advocate for local support for the nutrition plan to sustain nutrition improvement
5. Institute policies and programs and provide support to families with underweight children;
6. Monitor and oversee the I plans of actions and other PPAs being undertaken by the LGUs in the province;
7. Conduct capacity-building programs for all stakeholders involved in combating malnutrition;
8. Adopt an Annual Work Financial Plan for Nutrition to be submitted to the LGU for consideration and inclusion in AIP and local budget ordinance.

SECTION 3. MEETINGS. The Provincial Nutrition Committee shall conduct regular quarterly meetings. Special meetings may be conducted when necessary.


SECTION 4. SECRETARIAT. The Provincial Nutrition Officer, assisted by the Population Officer, and their staff shall act as the Secretariat of the PNC.

SECTION 5. Roles and functions of Secretariat.

1. Assist the Chairperson in the conduct of meetings;
2. Provide technical assistance in the performance of administrative and technical tasks;
3. Recommend and prepare agenda, and other similar documents during meetings;
4. Prepare resolutions of the Council and the minutes of the meeting;
5. Prepare and submit semestral Accomplishment Report;
6. Prepare and submit quarterly Secretariat Accomplishment Report;
7. Perform such other tasks as may be directed by the Council.

SECTION 6. Effectivity. This order shall take effect immediately upon signing hereof and remains effective and binding unless revoked, repealed or modified.
