**"RESOLUTION DECLARING THE PROVINCE OF TAWI-TAWI AS FREE FROM
 LOCAL TERRORIST GROUPS"**

WHEREAS, the Joint Peace and Security Coordinating Center (JPSC), Province of Tawi-Tawi composed of AFP, PNP, and PCG unanimously adopted Resolution No. 2024-1 entitled "Resolution Declaring the Whole Province of Tawi-Tawi as Free from the Local Terrorist Groups (LTG)"

WHEREAS; in adherence to the country's war against insurgency or the Local Terrorist Group (LTG), the Province of Tawi-Tawi is fully supportive with firm declaration and unwavering commitment on the promotion of peace, order and security to attain direction for progress and development;

WHEREAS, the Armed Forces of the Philippines, being the protector of the people and state plays a crucial role in preserving peace and harmony, by defending the country against terrorism and other forms of threat, whether of civilian or military nature;

WHEREAS, the Philippine National Police shall enforce the law, prevent and control crimes, maintain peace and order, and ensure public safety and internal security with the active support of the community;

WHEREAS, the Philippine Coast Guard is mandated and responsible to perform Maritime Search and Rescue, Maritime Law Enforcement, Maritime Safety, Marine Environmental Protection and Maritime Security;

WHEREAS, the Tawi-Tawi Police Provincial Office, Joint Task Group Atlas/2MBde and Philippine Coast Guard Tawi-Tawi through the Joint Peace and Security Coordinating Center (JPSCC) confirm the absence of Local Terrorist Groups (LTG) in all areas of Tawi-Tawi as manifested by the current peace and order situation in the province;

WHEREAS, the people of Tawi-Tawi have been very vocal about sustaining the current peace and development situation since they believe that this will be the key towards achieving a better tomorrow. Hence, it would be a logical opportunity for the Provincial Government to develop an Inter-Agency, Whole-of-Province declaration which will enhance the image of the people of Tawi-Tawi as peace-loving individuals while gradually transforming the province from a traditionally-perceived terrorist haven into a prime tourist and economic zone;

WHEREAS, programs, plans and implementation in partnership with the Local Government Units, line agencies, stakeholders and community consistent with the provision of Executive Order No. 70, Institutionalizing the Whole-of-nation Approach in Attaining Inclusive and Sustainable Peace, Creating a National Task Force to end Lical Community Armed Conflict, and Directing the Adoption of a National Peace Framework – and Retooled Community Support Program (RCSP) are demand-driven, responsive, genuine, inclusive and effective in the present situation of the province;


