RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE YSHMAEL I. SALI, TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR THE IMPLEMENTATION OF TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED WORKERS (TUPAD) PROGRAM TOTALING ONE MILLION PESOS (P1,000,000) IN THE PROVINCE OF TAWI-TAWI

Introduced by HON. MELHAN J. MASDAL

WHEREAS, The Department of Labor and Employment (DOLE), as the policy-coordinating arm of the Executive Branch in the field of labor and employment, introduced the DOLE Integrated Livelihood and Emergency Employment Program (DILEEP) that targets to produce massive job generation and poverty reduction;

WHEREAS, the Emergency Employment Program (EEP) or the *Tulong Panghanapbuhay sa Ating Disadvantage/Displaced Workers* (TUPAD), as one of the components of livelihood and entrepreneurship program under DILEEP, provides emergency employment for displaced workers, underemployed and unemployed poor for a minimum period of ten (10) days;

WHEREAS, the provincial government, under the administration of Provincial Governor Honorable Yshmael "Mang" I. Sali, acknowledges the number of unemployed constituents belonging to the poor, vulnerable and marginalized sectors who are in dire need of availing short-term employment, and agrees to implement the TUPAD program for the benefits of the general public;

WHEREAS, Provincial Employment Service Office (PESO), being the referral and information center for the various employment services and programs of the provincial government, will fulfill the said program and prepare all necessary documents in accordance with the approved program objectives, standards, systems, and procedures for implementation;

WHEREAS, there is a need to authorize the Local Chief Executive to enter into a Memorandum of Agreement with DOLE for the implementation of the DOLE-TUPAD Program totaling one million pesos (P1,000,000.00);

WHEREAS, Sec. 465 paragraph (b,1,vi) of the Local Government Code of 1991, the provincial governor is granted the power to represent the province in all its business transactions and sign on its behalf all contracts upon the authority of the sangguniang panlalawigan;




