RESOLUTION AUTHORIZING THE HONORABLE YSHMAEL I. SALI, PROVINCIAL GOVERNOR, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH DEED OF DONATION ON BEHALF OF THE PROVINCIAL GOVERNMENT OF TAWI-TAWI WITH THE DEPARTMENT OF HEALTH, REPRESENTED BY UNDERSECRETARY, DR. GLENN MATHEW G. BAGGAO, FOR THE ACCEPTANCE OF ONE (1) UNIT OF COASTER VAN CONVERTED INTO A MOBILE CLINIC

WHEREAS, the Department of Health (DOH) has developed the Mobile Primary Care Facility (MPCF) health program, which aims to provide timely and accessible medical care to the Filipino people, particularly those in geographically isolated and disadvantage areas;

WHEREAS, in furtherance of this program, the Department of Health donates converted coaster vans, known as Mobile Clinic, equipped with necessary medical equipment and supplies, to various government stakeholders to serve as extensions of the Provincial or City Hospitals for delivering primary health care services;

WHEREAS, the Department of Health recognized the particular need of the Province of Tawi – Tawi for a Mobile Clinic, given the geographical challenges faced by its residents, especially those from remote and disadvantage barangays, in accessing immediate medical care from hospitals;

WHEREAS, the donation of one (1) unit Mobile Clinic to the Provincial Government of Tawi – Tawi is subject to the terms and conditions stipulated by the Department of Health;

WHEREAS, pursuant to Section 465 (b)(1)(vi), Article I, Chapter 3 of the Local Government Code of 1991, the Provincial Governor, as the chief executive of the provincial government, has power to represent the province in all its business transactions and to sign in its behalf of all contracts, upon authority of the Sangguniang Panlalawigan;

WHEREAS, the Sangguniang Panlalawigan has been presented with a letter from the Honorable Yshmael I. Sali, Provincial Governor, and a letter from the Department of Health, signed by the Undersecretary Dr. Glenn Mathew G. Baggao, dated 11 June 2024, regarding the donation;

WHEREAS, the donation of one (1) unit Mobile Primary Care Facility (MPCF) will enhance access to healthcare, reduce patient waiting times, improve community health integration, and provide tailored, culturally sensitive care;

NOW, THEREFORE, BE IT RESOLVED by the Sangguniang Panlalawigan that the Honorable Yshmael I. Sali, Governor of the Province of Tawi – Tawi, be authorized to enter into and sign, on behalf of the Provincial Government of Tawi – Tawi, a **Memorandum of Agreement with a Deed of Donation with the Department of Health**, represented by Undersecretary, Dr. Glenn Mathew G. Baggao, for the acceptance of one (1) unit coaster van converted into a Mobile Clinic.

RESOLVED FURTHER, that copies of this resolution be furnished to the Office Provincial Governor and Department of Health for their information and appropriate action.
