A RESOLUTION AUTHORIZING MR. AHMAD J. BURAHIM - OIC PROVINCIAL TREASURER, AND MS. ANGELITA A. BAJANA - ADMINISTRATIVE OFFICER III, OF THE PROVINCIAL GOVERNMENT OF TAWI-TAWI TO SUBSCRIBE TO THE INTERNET BANKING FACILITY OF THE LAND BANK OF THE PHILIPPINES, KNOWN AS "WEACCESS", AND DESIGNATING AUTHORIZED SIGNATORIES AND USERS FOR THE SAME

WHEREAS, the Provincial Government of Tawi-Tawi recognizes the importance of adopting modern banking facilities to ensure efficient financial management and secure transactions;

WHEREAS, the Land Bank of the Philippines (LBP), provides an internet banking facility known as "weAccess", offering secure and convenient access to various banking services;

WHEREAS, the Provincial Government of Tawi-Tawi deems it necessary and advantageous to subscribe to LBP's "weAccess" facility to enhance its financial operations and streamline its banking processes;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, to authorize the following:

1. Subscription to the Land Bank of the Philippines' (LBP's) internet banking facility known as "weAccess"; and
2. Designation of authorized signatories to enroll and authorized user/s in the LBP's "weAccess".

RESOLVED, FURTHER, to authorize **MR. AHMAD J. BURAHIM - OIC PROVINCIAL TREASURER, AND MS. ANGELITA A. BAJANA - ADMINISTRATIVE OFFICER III**, to perform the following:

1. Execute and sign all documents necessary to subscribe to LBP's "weAccess" facility;
2. Designate and authorize personnel to act as "maker" or "authorizer" for the Provincial Government's access to LBP's "weAccess" banking facility; and
3. Amend, add, or delete enrolled deposit account/s as source and/or destination account/s, access rights to the "weAccess" modules, authorization rules, and/or any information on the original and succeeding enrollments.


