RESOLUTION

**STRONGLY REQUESTING THE POLICE DIRECTOR, PHILIPPINE NATIONAL POLICE (PNP) TO ESTABLISH A NARCOTIC MINI-LAB IN PNP TAWI-TAWI COMMAND, BONGAO, TAWI-TAWI IN ORDER TO PROVIDE TECHNICAL OR SCIENTIFIC EXPERTISE ON ILLEGAL DRUG DETECTION OR EXAMINATION AND TO CONSTITUTE THIS UNIT AS AN INDISPENSABLE COMPONENT OF TAWI-TAWI PROVINCIAL GOVERNMENT CAMPAIGN AGAINST ILLEGAL DRUG TRAFFICKING AND ADDICTION**

**WHEREAS**, illegal drug-trafficking and addiction is now a widespread social menace in the province of Tawi-Tawi which should be addressed with resoluteness and determination by all concerned government agencies as well as NGO's;

**WHEREAS**, the Provincial Government of Tawi-Tawi is spearheading an intensified and integrated campaign against illegal drug trafficking and addiction through its organized Task Force known as **TASK GROUP BATO** which was recently formed by the Provincial Government of Tawi-Tawi;

**WHEREAS**, in order to provide technical or scientific expertise on illegal drug detection examination and apprehension;

**WHEREAS**, the establishment of a Narcotic Mini-Lab in the PNP Unit in Tawi-Tawi is considered a necessary and an indispensable component to attain an effective and successful campaign against illegal drug trafficking and addiction since the necessity to send confiscated illegal drugs need not be sent to Zamboanga for laboratory examination;


**NOW THEREFORE**

On session duly assembled, **RESOLVED**, as it hereby resolved, to strongly request the Police Director, Philippine National Police (PNP) to establish a Narcotic Mini-Lab in PNP Tawi-Tawi Command, Bongao, Tawi-Tawi in order to provide technical or scientific expertise on illegal drug detection or examination and to constitute this unit as an indispensable component of Tawi-Tawi Provincial Government campaign against illegal drug trafficking and addiction.


**RESOLVED FURTHER**, that copy of this resolution be forwarded to the Police/Director Roberto T. Lastimoso, Philippine National Police (PNP), Camp Crame, Quezon City. Same copy be furnish to the PNP Provincial Director.
