APPROVING AND ADOPTING THE FIRST TAWI-TAWI PROVINCIAL
GOVERNMENT COMPREHENSIVE DEVELOPMENT PLAN (1999-2008)

WHEREAS, upon the representation of the Provincial Development Council of the Province of Tawi-Tawi favorably endorsing the approval and immediate adoption of the First Tawi-Tawi Provincial Government Comprehensive Development Plan (1999-2008) formulating the direction of the social and economic development efforts in the Province of Tawi-Tawi;

WHEREAS, pursuant to the Local Government Code of the Philippines and the 1995 Local Government Code of the Autonomous Region in Muslim Mindanao by which the Provincial Development Council is directed to formulate a comprehensive development plan, integrating the medium term development plans of all Municipal Development Councils Line Agencies in the province and that the Sangguniang Panlalawigan is tasked to review the Plan and enact the necessary resolution approving and adopting the same;

WHEREAS, the Tawi-Tawi Provincial Comprehensive Development Plan (1999-2008) contains the Provincial Development Framework Plan which embodies the goals and objectives, policies and strategies, major programs and projects, and the proposed investment programs and projects of the different municipalities which when pursued and implemented would spur social and economic development in the province and uplift the well-being of the people;

WHEREAS, the National and Regional Governments and their agencies, namely, the National Economic Development Authority, the Department of Budget and Management, the Regional Planning and Development Board and the Regional Legislative Assembly, Autonomous Region in Muslim Mindanao have required immediate submission to them of the plan by the provincial government of Tawi-Tawi for approval and integration into the Philippine and ARMM Development Plans as well as to facilitate appropriation or allocation and release of funds for priority programs and projects selected therefrom;


NOW THEREFORE
