RESOLUTION REQUESTING TO DEFER THE RELIEVE/TRANSFER OF CAPT FELICIANO A ANGUE, PN (JSC) AS COMMANDER OF TASK FORCE 62, NAVAL STATION BATO-BATO, PANGLIMA SUGALA, TAWI-TAWI

WHEREAS, the Sangguniang Panlalawigan of Tawi-Tawi as Legislative body duly organized and recognized according to law, shall approve ordinances and pass resolutions necessary for an efficient and effective provincial government and, in this connection shall maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition pursuant to Section 468 (1)(ii) of the LGC of 1991;

WHEREAS, Task Force 62 headed by CAPT FELICIANO A ANGUE, PN (JSC) have been instrumental in the pursuit for peace and order in the Province of Tawi-Tawi;

WHEREAS, in recognition of his meritorious services, the Province of Tawi-Tawi, awarded him a COMMENDATION thru Resolution No. 002, series of 2004;

WHEREAS, there is a continuing quest for Peace and Order in the Province of Tawi-Tawi as it is being threatened by various terrorist groups and other lawless elements;

WHEREAS, a rapport have been established between the Provincial Government and other Local Government Units of the Province of Tawi-Tawi and the Task Force 62 in terms of consultation and coordination which necessitates sustainability;

WHEREAS, it is believed that the presence of Task Force 62 under the able leadership of CAPT FELICIANO A ANGUE, PN (JSC) should be maintained for the implementation of its various plans and programs, for the success of its Peace and Order campaign, thus the necessity to defer the relieved or transfer of its Commander.
