RESOLUTION No. 02

APPROVING MONTHLY APPROPRIATION FOR THE MAINTENANCE, OPERATING, AND OTHER EXPENDITURES (MOOE's) OF THE MEMBERS OF THE SANGGUNIANG PANLALAWIGAN IN THE TOTAL AMOUNT OF ONE MILLION SEVEN HUNDRED SEVENTY FIVE THOUSAND PESOS (P1,775,000.00), TO BE APPORTION AS FOLLOWS: P300,000.00 FOR THE VICE-GOVERNOR; P150,000.00 FOR EACH OF THE EIGHT (8) REGULAR SANGGUNIANG MEMBERS; P75,000.00 FOR EACH OF THE EX-OFFICIO MEMBERS; AND P50,000.00 FOR SANGGUNIANG PANLALAWIGAN SECRETARY, EFFECTIVE JANUARY, 2002

WHEREAS, the Sangguniang Panlalawigan of the Province of Tawi-Tawi is composed of Provincial Vice-Governor as Presiding Officer, eight (8) regular Sangguniang Members, and three (3) Ex-Officio Members, namely; the President of the Provincial Chapter of the Liga ng mga Barangay, the President of the Provincial Federation of the Sangguniang Kabataan, and the President of the Provincial Federation of the Sangguniang Members of Municipalities and component cities;

WHEREAS, the Sangguniang Panlalawigan, as the legislative body of the Province, enacts ordinances, passes resolutions, and appropriate funds for the general welfare of the province and its inhabitants;

WHEREAS, in the exercise of their legislative functions, the SP Members should undertake these various activities, such as, extensive travels both within and outside of the province for seminars, trainings, and / or speaking engagements; conduct research and consultations or public hearings in aid of legislations;

WHEREAS, regular SP Members are usually presented by their constituents with project proposals requiring funding assistance, or are asked for donations by social and civic organization, for which their MOOE's will be used.

NOW THEREFORE

On session duly assembled, **RESOLVED, AS IT IS HEREBY RESOLVED**, to approved the monthly appropriation in the amount of one million seven hundred seventy five thousand pesos (P1,775,000.00) for the maintenance, operating, and other expenditures (MOOE's) of the members of the Sangguniang Panlalawigan.

ADOPTED this 6th day of February 2002 on motion of Honorable Hadji Jilkasi J. Usman and duly seconded by Honorable Hadji Yacob S. Harun.
