RESOLUTION

RESOLUTION DECLARING SANGAY SIYAPO AND LA, MUNUCIPALITY OF
SIMUNUL, AND PANAMPANGAN, MUNICIPALITY OF SAPA-SAPA, PROVINCE OF
TAWI-TAWI AS PROTECTED AREAS

WHEREAS, the Sangguniang Panlalawigan, as the legislative body of the province, shall enact ordinances, approved resolutions and appropriate funds for the general welfare of the province and its inhabitants pursuant to the Local Government Code of 1991;

WHEREAS, the Sangguniang Panlalawigan shall approve ordinances and pass resolutions necessary for an efficient and effective government and, in this connection shall protect the environment and impose appropriate penalties for acts which endanger the environment, such as dynamite fishing and other forms of destructive fishing and such other activities which result in pollution, acceleration of entrophication of rivers and lakes, or of ecological imbalance pursuant to Section 468(i)(vi) of the Local Government Code of 1991;

WHEREAS, the areas of Sangay Siyapo and LA located at the municipality of Simunul and Panampangan located at the municipality of Sapa-Sapa, Province of Tawi-Tawi had been subjected to destructive forms of fishing such as the use of dynamite and cyanide.

NOW THEREFORE

ON SESSION DULY ASSEMBLED, RESOLVED AS IT IS HEREBY RESOLVED, to approved the resolution declaring SANGAY SIYAPO AND LA, MUNICIPALITY OF SIMUNUL AND PANAMPANGAN, MUNICIPALITY OF SAPA-SAPA, PROVINCE OF TAWI-TAWI AS PROTECTED AREAS.

RESOLVED FURTHER, that copies of this resolution be furnished the Department of Agriculture and Fisheries (DAF), the Department of Environment and Natural Resources, the Philippine National Police, the Philippine Marines and other agencies of similar concern.
