RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR HADJI SADIKUL A. SAHALI TO RELEASE THE AMOUNT OF ONE HUNDRED SEVENTY THOUSAND PESOS (Php 170,000.00) FOR THE PAYMENT OF HONORARIUM OF THE MEMBERS OF THE COMMITTEE TO DRAFT THE PROPOSED PROVINCIAL ORDINANCE PRESCRIBING FOR THE DOWRY SYSTEM INVOLVING ELOPEMENT IN ACCORDANCE WITH THE TRADITIONAL MARRIAGE PRACTICES AND OTHER RELATED MATTERS

**WHEREAS**, the Sangguniang Panlalawigan, as the Legislative Body of the province, shall enact ordinance, approve resolution and appropriate funds necessary for an efficient and effective provincial government pursuant to Sec. 468, (1), (viii) of Republic Act 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, a committee with thirty four (34) members has been created by virtue of Memorandum Order No. 01, series of 2004 to draft a proposed provincial ordinance and the members were entitled to an honorarium of five thousand pesos (Php 5,000.00) each.

**NOW THEREFORE**, on motion duly seconded, be it

**RESOLVED**, as it is hereby resolved, to AUTHORIZE THE HONORABLE GOVERNOR HADJI SADIKUL A. SAHALI TO RELEASE THE AMOUNT OF ONE HUNDRED SEVENTY THOUSAND PESOS (Php 170,000.00) FOR THE PAYMENT OF HONORARIUM OF THE MEMBERS OF THE COMMITTEE TO DRAFT THE PROPOSED PROVINCIAL ORDINANCE PRESCRIBING FOR THE DOWRY SYSTEM INVOLVING ELOPEMENT IN ACCORDANCE WITH THE TRADITIONAL MARRIAGE PRACTICES AND OTHER RELATED MATTERS.
