WHEREAS, Section 45, (a), (b) of the Local Government Code of 1991 provides for the filling-up of permanent vacancies in the Sanggunian;



RESOLVED FURTHER, copy of this resolution be forwarded to the Office of the Honorable Governor, Rashidin H. Matba for his favorable consideration and action.


