WHEREAS, the Project Title: Read, Understand and Begin Young (RUBY): A Reading Recovery Program for Poor Readers in the Division of Tawi-Tawi is build upon the Autonomous Region in Muslim Mindanao (ARMM) Reading Program which aims to provide a reading recovery intervention in order to improve the reading proficiency of the target population and prepare them for the next grade level;
