A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR SADIKUL A. SAHALI, AL-HAJ, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS – ARRM (DOTC-ARRM) FOR THE IMPLEMENTATION OF THE PROJECTS NAMELY: (1) BONGAO PORT – PHP 15 MILLION, (2) SITANGKAI PORT – PHP 15 MILLION, (3) MAPUN PORT – PHP 20 MILLION, (4) BATO-BATO PORT – PHP 30 MILLION RESPECTIVELY.

WHEREAS, the Provincial Government of Tawi-Tawi have embarked into socio-economic and infrastructure projects designed to benefit the people of Tawi-Tawi;

WHEREAS, by the virtue of power vested in the Sangguniang Panlalawigan of Tawi-Tawi as provided for by R.A. No. 7160 and other laws appurtenant thereto hereby authorize the Honorable Governor Sadikul A. Sahali, Al-Haj, to enter into a Memorandum of Agreement (MOA) with the Department of Transportation and Communications – ARMM (DOTC-ARRM) for the implementation of the Projects namely; (1) Bongao Port – Php 15 Million, (2) Sitangkai Port – Php 15 Million, (3) Mapun Port – Php 20 Million, (4) Bato-Bato Port – Php 30 Million respectively.


NOWTHEREFORE, on motion duly seconded, be it,
