NOW THEREFORE, after due deliberation of the proposal and finding the same to be beneficial to the welfare of the people, on motion duly seconded, it was –

RESOLVED, as it is **HEREBY RESOLVED** by the Sanggunian Panlalawigan in its 14th Regular Session duly assembled to that the Provincial Governor and the Provincial Treasurer of the Province of Tawi-Tawi to Withdraw, encash and transact other official business relative to the Provincial Government financial operations with the Land Bank of the Philippines, Bongao, Tawi-Tawi Branch;
