### **RESOLUTION**

**CONFIRMING THE COMMITMENT OF THE PROVINCIAL GOVERNMENT OF TAWI-TAWI TO RESERVE OR TO PROVIDE ONE HUNDRED (100) HECTARES OF LAND FOR THE PURPOSE OF ESTABLISHING A PILOT PROVINCIAL INDUSTRIAL CENTER (PICs) IN THE MUNICIPALITIES OF PANGLIMA SUGALA AND BONGAO, TAWI-TAWI**

**WHEREAS**, the establishment of an Industrial Center was identified in the Province's Comprehensive Development Plan as a priority project aimed at opening the Province of Tawi-Tawi to industrialization to speed-up the realization of its development objectives;

**WHEREAS**, the strategic location of the Province of Tawi-Tawi in the BIMPE-EAGA Region and its proximity to Malaysia, Indonesia and other Asean countries make the province an ideal place for the establishment of an industrial center;

**WHEREAS**, the province of Tawi-Tawi possesses abundant resources, especially agricultural, aquatic and marine and fisheries products (seaweed) that can sustain the needs of an industrial center;

**WHEREAS**, the stability of the peace and order in the province of Tawi-Tawi, which is one of the most peaceful provinces in the country, will be most conducive for the establishment and development of an industrial center;

**WHEREAS**, the establishment of an industrial center will generate the much-needed employment and livelihood opportunities for the people of Tawi-Tawi, which in turn, will help boost the socio-economic development of the province.


**NOW THEREFORE**

On session duly assembled, **RESOLVED, AS IT HEREBY RESOLVED**, to confirm the commitment of the Provincial Government of Tawi-Tawi to reserve or to provide one hundred (100) hectares of land for the purpose of establishing a Pilot Provincial Industrial Center (PICs) in the Municipalities of Panglima Sugala and Bongao, Tawi-Tawi.
