A RESOLUTION DIRECTING ALL LOCAL CHIEF EXECUTIVES OF THE DIFFERENT MUNICIPALITIES IN THE PROVINCE OF TAWI-TAWI TO ORGANIZE AND INSTITUTIONALIZE THEIR RESPECTIVE MUNICIPAL TOURISM OFFICE

SPONSORED BY: HON. MYRNA C. AJIHIL

WHEREAS, Section 33, Article 3, Chapter 3 of the Local Government Code provides that "local government units may through appropriate ordinances organize the Municipal Tourism Office for in "consolidating or coordinate their efforts, services, and resources for purposes commonly beneficial to them";

WHEREAS, the Provincial Development Council based on voluntary , consensus-based and collaborative approaches in integrated area development that is focused on eleven (11) areas of collaboration, namely: Basic Services Delivery, Environmental Management, Public Safety and Security, Land Use Management, Infrastructure Development, Economic and Tourism Promotion and Development;

WHEREAS, the Provincial Government encourages the participation of multi-stakeholders in accelerating the economic and social growth and development of the Provinces;

WHEREAS, the Tawi-Tawi Tourism Council was similarly organized to effect mutually beneficial economic development with special focus on tourism;

WHEREAS, the Tawi-Tawi Tourism Council has similarly recognized the importance of tourism development to overall economic development;

WHEREAS, the Tawi-Tawi Tourism Council recognizes the need to collaborate on certain specific areas in order to speed-up the economic and tourism development of the Provinces;

WHEREAS, the National Government has unveiled a massive investment program to sustain economic growth, speed progress to all areas of the country through the Mega-Region Economic Development Strategy and propel the Philippines to the "First World" status and through such development strategy, make funds available through the Medium-Term Public Investment Program (MTPIP);

WHEREAS, Tawi-Tawi, where tourism has been identified, has an inherent competitive edge and priority area for investments;

WHEREAS, the tourism industry development will depend highly on the effectiveness of the inter-local government cooperation which can support the developmental thrust of the Provincial Government;

WHEREAS, as existing and functional Council has emerged and expanded to help realize the goals and objectives of Provincial Tourism Office through economies of scale.

SECTION 1. The Provincial Tourism Office in collaboration with Tawi-Tawi Tourism Council shall formulate, coordinate and monitor programs, projects and activities, and facilitate the organization of the Municipal Tourism Office of each of the eleven (11) municipalities of the province in order to accelerate the tourism industry development; and

SECTION 2. In the discharge of its functions, the Municipal Tourism Office shall ensure appropriate coordination with the Provincial Tourism Council, the Provincial Development Council (PDC) of Tawi-Tawi and other relevant local development councils;

NOW THEREFORE, on motion of Hon. Myrna C. Ajihil, duly seconded by Hon. Rodolfo A. Bawasanta, be it resolved, as it is hereby resolved, that the Sangguniang Panlalawigan of Tawi-Tawi approved this Resolution.




