**A RESOLUTION EXPRESSING FULL SUPPORT TO THE MINING OPERATION OF SR LANGUYAN MINING CORPORATION, SITUATED AT BARANGAYS TUMBAGAAN, ADNIN, AND OTHER BARANGAYS OF LANGUYAN MUNICIPALITY, TAWI-TAWI PROVINCE, COVERED BY THE MINERAL PRODUCTION SHARING AGREEMENT (MPSA) NO. 04-ARMM-07.**

**SPONSORED BY: Hon. ALGARAD O. LIPAE**

**WHEREAS**, in cognizance to the recent order lifting suspension of the mining operation of the SR Languyan Mining Corporation by the present leadership of the Honorable OIC, Regional Governor MUJIV S. HATAMAN, and after a substantial review and mandatory conduct of public consultations from among the Civil Society Organization and other Stakeholders directly affected in the areas, the committee of the whole, headed by Honorable Algarad O. Lipae, Chairperson, Committee on Environment and Natural Resources, was in unanimous

agreement to fully support the said mining operation, finding the same that it would bring about economic advancements, and equally, provide clear job opportunities for the people of the province, it being identified as one of the poorest political unit in the country; and that the full support as herein expressly manifested, shall however, establish a working parameters, which shall direct the contracting party (SR Languyan Mining Corporation), to religiously maintain the strict conditions as hereunder stated as follows, to wit:

- a. That the mining operation shall provide a workable program that would protect the ecological balance of the premises, particularly the reserve coral reefs surrounding the island where the mining operation is situated;
- b. That employment requirements of the mining operations, shall be given utmost preference to the residents of the place, and all other interested Tawi-Tawi citizens that may desire to seek employment with the operation;
- c. That no dislocation/displacement of local residents be affected by the mining concession, with paramount consideration of providing basic social services for the entire stakeholders of Tawi-Tawi Province;
- d. And finally, that present mining activity shall be strictly limited to Barangay Tumbagaan and any mining activity outside the area shall be discussed further.


**NOW, THEREFORE**, on motion duly seconded,


