A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR HADJI SADIKUL A. SAHALI TO LOAN FROM LAND BANK OF THE PHILIPPINES AN AMOUNT OF FIFTY MILLION PESOS (P50,000,000.00) FOR THE CONSTRUCTION OF FIFTY (50) SCHOOL BUILDING INTENDED FOR ONE HUNDRED (100) CLASSROOMS, AND THREE (3) PUBLIC MARKET FOR THIRTY MILLION PESOS (P30,000,000.00)

WHEREAS, the Sangguniang Panlalawigan as the Local Legislative Body of the Province of Tawi-Tawi shall enact ordinance, approve resolution and appropriate funds necessary for an effective and efficient Provincial Government and in this connection, shall determine the powers, duties, positions, salaries and wages, allowances and other emoluments and benefits of officials and employees of the Province pursuant to Section 468 (1), (vii), (viii) of R.A. 7160 also known as the Local Government Code of 1991;

WHEREAS, the basic law of the land provides that "the State shall protect and promote the right of all citizen to quality education at all levels and shall take appropriate steps to make such education accessible to all". The Provincial Government of Tawi-Tawi

had express collective interest for the construction of fifty (50) school building allotted to One Hundred (100) classrooms for high school and elementary school.

WHEREAS, the recent school erected in the domain of Tawi-Tawi, there are eighteen (18) Island School Districts separated by vast seas. The academic institution formulated in our domain with the total number existing school buildings (21 for National High School, 20 Mindanao State University and has a total of 225 Elementary schools) with this situation, it is impossible to accommodate the total Number of enrollees every year.

WHEREAS, the Provincial Government of Tawi-Tawi was ignited to proposed fifty (50) school buildings and found out to be feasible to enhance the basic needs of quality education in the province to inculcate among the youth the value of education.

WHEREAS, knowingly the value of education should seek to inculcate in public for patriotism and development, upgrading the system, construct building and pinpointing government priorities in the allocation of scare resources to place emphasis on basic education, would bring a quantum leap for the Province of Tawi-Tawi.

WHEREAS, Bongao Municipality as the center of trade and commerce and the provincial capital town of Tawi-Tawi with its vast and rapid growth of population is need of more convenient Public Market which contribute to the progressive of Trade and Commerce of the whole Province. It is also followed, with the Municipality of Panglima Sugala and the Municipality of Mapun.

WHEREAS, on motion made by Honorable Alhamar M. Tamburani, Committee Chairman on Education, and Honorable Hadja Myrna C. Ajilhil, Committee Chairman on Public Works and Infrastructures and duly seconded by Hon. Algarad O. Lipae.

NOW THEREFORE, on motion duly assembled, be it

RESOLVED, AS IT IS HEREBY RESOLVED, to request the honorable Sangguniang Panlalawigan of Tawi-Tawi through Honorable Governor Sadikul A. Sahali to loan for the amount of Fifty Million Pesos (P50,000,000.00) for the construction of fifty (50) school buildings, intended for one hundred classrooms (100) within the Province of Tawi-Tawi and three (3) Public Market located in three (3) Municipalities for an amount of Thirty Million Pesos (P30,000,000.00), namely as follows:




RESOLVE FURTHER, to transmit this resolution to the Honorable Governor Sadikul A. Sahali for his information and favorable consideration.


