A RESOLUTION ENJOINING THE HONORABLE MAYOR MIBARAL M. TANG, MUNICIPALITY OF TURTLE ISLANDS, TAWI-TAWI TO CEASE AND DESIST FROM THE CONSTRUCTION OF ANY STRUCTURE ON THE VERY SITE FOR TAGANAK PORT PROJECT IN THE INTEREST OF THE GENERAL PUBLIC.

WHEREAS, The Provincial Government of Tawi-Tawi have embarked on various infrastructure programs and projects along with its quest for Peace, Progress and Sustainable Development for the betterment of the lives of Tawi-Tawians;

WHEREAS, the Sangguniang Panlalawigan of the Province of Tawi-Tawi had authorized the Provincial Governor Nurbert M. Sahali to enter into a Memorandum of Agreement (MOA) with the Department of Transportation and Communication (DOTC) for the construction of Taganak Port, Taganak, Turtle Island, Tawi-Tawi pursuant to SP Resolution No. 011 Series of 2015 and SP Resolution No. 016 Series of 2015 with approved appropriation from the General Appropriation Act of 2015 amounting to One Hundred and Nine Million Pesos (Php 109, 000, 000.00) in totality;

WHEREAS, there is a reported construction of a footbridge on the site which has been surveyed and validated to be the proposed area for the construction of Taganak Port, Taganak, Turtle Island, Tawi-Tawi which is due for implementation now, as all appropriations thereof had already been approved;


NOW, THEREFORE, on motion of Honorable Hadji Abdulajid J. Jaji and duly seconded unanimously, be it;

RESOLVED, as it is hereby RESOLVED, TO ENJOIN THE HONORABLE MAYOR MIBARAL M. TANG, MUNICIPALITY OF TURTLE ISLANDS, TAWI-TAWI TO CEASE AND DESIST FROM THE CONSTRUCTION OF ANY STRUCTURE ON THE VERY SITE FOR TAGANAK PORT PROJECT IN THE INTEREST OF THE GENERAL PUBLIC.


