A RESOLUTION REQUESTING THE OFFICE OF THE PROVINCIAL GOVERNOR, THIS PROVINCE THRU THE SANGGUNIANG PANLALAWIGAN TO APPEAL THE SENTIMENTS OF THE PEACE-LOVING PEOPLE OF SITANGKAI TO THE OFFICES OF THE DIFFERENT SHIPPING LINES OPERATING AND DEPART FROM THE CAPITAL TOWN OF BONGAO TO SITANGKAI PORT, VICE-VERSA, MUNICIPALITY OF SITANGKAI, PROVINCE OF TAWI-TAWI TO REDUCE COMMERCIAL MOTOR VESSEL'S FARE RATE FROM THE PRESENT THREE HUNDRED PESOS (PHP300.00) TO THE REASONABLE RATE OF ONE HUNDRED FIFTY PESOS (PHP150.00) PER PASSENGER






