A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NURBERT M. SAHALI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AS THE REPRESENTATIVE OF THE PROVINCE OF TAWI-TAWI WITH DATU HALUN SAKILAN MEMORIAL HOSPITAL (DHSMH), THE TAWI-TAWI PROVINCIAL POLICE OFFICE (TTPPO) AND THE CHILD PROTECTION NETWORK FOUNDATION, INC. (CPN) FOR COLLABORATION ON A PROGRAM TO PROVIDE ASSISTANCE AND SUPPORT INTERVENTION TO WOMEN AND CHILDREN SURVIVORS TO ABUSE AND THEIR FAMILIES.

WHEREAS, the Provincial Government of Tawi-Tawi is tasked by Republic Acts 7160 (Local Government Code of 1991), 9208 (Anti-Child Abuse Law), 8353 (Anti-Rape Law), 8505 (Rape Victim Assistance and Protection Act), and 9282 (Violence Against Women and their Children Act), with the investigation of child abuse and violence against women and other similar crimes within its territorial jurisdiction;

WHEREAS, the Datu Halun Sakilan Memorial Hospital (DHSMH) is charged with providing quality medical and health care and attention to Tawi-Tawi residents and all patients coming to it for medical treatment and assistance;

WHEREAS, under the Philippine National Police (PNP), the Tawi-Tawi Provincial Police Office (TTPPO) is tasked to enforce all law and ordinances relative to the protection and of lives and properties, maintain peace and order and take all necessary steps to ensure public safety, investigate and prevent crimes, affect the arrest and criminal offenders, and bring offenders to justice and assist in their prosecution; among others;

WHEREAS, the Child Protection Network Foundation, Inc. (CPN) supports the Province of Tawi-Tawi in fulfilling the latter's duties and initiatives directed towards promoting crime prevention, keeping the constituents healthy, and assisting victims;

WHEREAS, the parties aim to collaborate on a program that will enhance the capacity to provide assistance and support intervention to women and children survivors of abuse and their families;

WHEREAS, pursuant to Republic Act 7160 (Local Government Code of 1991) Section 468 (a), (4), (vi), the Sangguniang Panlalawigan shall approve radiances and pass resolutions necessary for an effective and efficient provincial government, shall ensure the effective and efficient delivery of basic services and facilities as provided for under Section 17 of the Code, and, in addition to said services and facilities, shall; provide for the care of paupers, the aged, the sick, persons of unsound mind, abandoned minors, abused children, disabled persons, juvenile delinquents, drug dependents, and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of aged;


Subject to availability of funds, establish and support the operations of centers and facilities for said needy and disadvantaged persons; and facilitate efforts to promote the welfare of families below the poverty threshold, the disadvantaged and the exploited.

NOW, THEREFORE, on motion of Honorable HJA. GANDA A. JAANI and duly seconded by the Honorable MIMANG B. NAWANG, be it;


RESOLVED, as it is hereby RESOLVED, to authorize the Honorable Governor Nurbert M. Sahali to enter into a Memorandum of Agreement (MOA) as the representative of the Province of Tawi-Tawi with Datu Halun Sakilan Memorial Hospital (DHSMH), the Tawi-Tawi Provincial Police Office (TTPPO) and the Child Protection Network Foundation Inc. (CPN) for collaboration and support intervention to women and children survivors of abuse and their families.


