A RESOLUTION SUPPORTING THE EXECUTION OF THE DEED OF DONATION EXECUTED BY AND BETWEEN WILMA GO AND CIVIL SERVICE COMMISSION (CSC) FIELD OFFICE FOR TAWI-TAWI (ARMM) AS DONOR AND DONEE TO SET UP A PERMANENT AND EXCLUSIVE STRUCTURE FOR THE FIELD OFFICE OF BONGAO, TAWI-TAWI.

WHEREAS, the Civil Service Commission-Regional Office No. 16 (CSC- ARMM), pursuant to Section IX-B of the 1987 Philippine Constitution, has the mandate to promote, the efficiency, integrity, responsiveness, progressiveness and courtesy in the civil service.

WHEREAS, to be efficient in the delivery of its basic services in the Province of Tawi-Tawi, the CSC-ARMM has set up its Field Office for the province of Tawi-Tawi in Bongao, but has no permanent and exclusive structure therefore;

WHEREAS, by virtue of deed of donation executed by and between WILMA GO and CSC ARMM as Donor and Donee, respectively, dated 20 July 2000, a portion of a parcel of land originally owned by the former under TCT No. T-95 located at Capitol Hill, Tubig-Boh, Bongao, Tawi-Tawi was donated to the latter, for the purpose of establishing a construction site as the permanent office of the Civil Service Commission Field Office for Tawi-Tawi.

WHEREAS, said Deed of Donation was never enforced up to this date;

WHEREAS, it is the desire of Provincial Government of Tawi-Tawi to give effect to the earlier intention of the original owner and donor, WILMA GO, to donate a portion of her lot to the CSC-ARMM for the construction of the latter's Field Office for Tawi-Tawi.


NOW THEREFORE, on motion of **HON. ELMASIA L. MADJILON** and duly seconded by **HON. HJA. GANDA A. JAANI**, be it;

RESOLVED, as it is hereby resolved, to support the execution of the Deed of Donation executed by, and between WILMA GO and Civil Service Commission (CSC) Field Office for Tawi-Tawi (ARMM) as Donor and Donee to set up a permanent and exclusive structure for the Field Office of Bongao, Tawi-Tawi.


RESOLVED FURTHER, that copies of this Resolution be furnished MS. WILMA GO, the CSC-ARMM and the Office of the **Honorable Governor NURBERT M. SAHALI** for information and favorable consideration.


