A RESOLUTION ALLOCATING AND AUTHORIZING THE USE OF A PORTION OF A PARCEL OF LAND FORMERLY OCCUPIED BY THE PROVINCIAL JAIL LOCATED AT CAPITOL HILL, BONGAO, TAWI-TAWI FOR THE CONSTRUCTION OF THE HALL OF JUSTICE IN THE PROVINCE OF TAWI-TAWI

SPONSORED BY: Hon. HJA. GANDA A. JAANI

WHEREAS, the Sangguniang Panlalawigan as the Legislative Body of the Province shall enact ordinances, approved resolutions and appropriate funds for the general welfare of the Province and its inhabitants and shall exercise corporate powers pursuant to section 12, section 16, section 22 and section 468 of the Republic Act 7160 otherwise known as Local Government Code of 1991;

WHEREAS, in the promotion of justice and maintenance of Peace and Order, it is deemed important and necessary to have a Hall of Justice in the Province of Tawi-Tawi and the Provincial Government of Tawi-Tawi realizes its active role for the attainment of this goal;

NOW THEREFORE, on motion of **HON. HJA. GANDA J. JAANI** and duly seconded by **HON. ELMASIA L. MADJILON**, be it;

RESOLVED, as it is hereby resolved, to allocate and authorize the use of a portion of a parcel of land formerly occupied by the Provincial Jail located at Capitol Hill, Bongao, Tawi-Tawi for the construction of the Hall of Justice in the Province of Tawi-Tawi.

RESOLVED FURTHER, that copies of this Resolution be furnished the Office of the Chairperson, Oversight Committee on Hall of Justice, Supreme Court of the Philippines, Padre Fauna St., Ermita, Manila, Office of the Honorable Congresswoman HJA RUBY M. SAHALI, Lone District of Tawi-Tawi, Batasang Pambansa, Quezon City.


