WHEREAS, pursuant to section Executive order no. 201, series of 2016. the Modified Salary Schedule authorized therein shall apply to all civilian personnel in the executive, legislative and other constitutional offices, government-owned and controlled corporation (GOCCS) and local government units (LGU’S) regardless of the appointment status, whether regular, contractual or casual, appointive or elective and on full time or partial basis;

WHEREAS, it is the principle and policy of the government to give just and equitable compensation to all government personnel in accordance with the principle equal pay for work of equal value and in order to attract retain and motivate competent and committed public servant;


WHEREAS, section 10 of the executive order 201 state that the modified salary schedule and additional benefits authorized therein for civilian personnel may likewise be granted to LGU personnel subject to authorization from their respective Sangguniang as provided under R.A. No. 7160;


WHEREAS, the implementation of the modified salary schedule for LGU personnel, including the rate of representation and transportation allowances shall further correspond to the LGU income classification and shall not therefore exceed the percentage of salary schedule under Section 3 of the Executive Order No. 201;




