STRONGLY PETITIONING THE MANAGEMENT OF AIR PHILIPPINES  
TO ESTABLISH FLIGHT ROUTE FROM ZAMBOANGA TO TAWI-TAWI  
AND VICE-VERSA

WHEREAS, good communication networks and efficient transportation systems or facilities are vital component of social and economic development requirements;

WHEREAS, the cancellation of PAL flights from Zamboanga to Tawi-Tawi and vice-versa effective June 1998, and which continues to the present, has cause severe economic dislocations for the business and tourism industries in the province of Tawi-Tawi, and hampered the fast movements of the traveling public and commuters;

WHEREAS, the continued cancellation of PAL flights to Tawi-Tawi has also deprived our people of vital and reliable information available only through the print media;

WHEREAS, the establishment of flight route by Air Philippines to Tawi-Tawi will rapidly connect Tawi-Tawi, being

the southern most part of the Philippines, to the rest of the country, and will enhance the economic and tourism development program;


NOW THEREFORE,




